## **PROPOSAL**

### **Re: Supplementation and adjustment of the business lines of Machines and Industrial Equipment Corporation**

To: The 2026 Annual General Meeting of Shareholders  
Machines and Industrial Equipment Corporation

*Pursuant to the Law on Enterprises 2020 and its amendments and supplements;*

*Pursuant to Decision No. 36/2025/QĐ-TTg of the Prime Minister promulgating the Vietnam Standard Industrial Classification System;*

*Pursuant to the Charter on Organization and Operation dated June 21, 2021 and the amendments and supplements to the Charter of Machines and Industrial Equipment Corporation (the Corporation);*

*Pursuant to Resolution No. 19/NQ-MIE-HĐQT dated May 11, 2026 of the Board of Directors of The Machines and Industrial Equipment Corporation regarding the approval of documents and the submission to SCIC for approval to serve the organization of the 2026 Annual General Meeting of Shareholders.*

#### **1. Current status:**

Currently, the Corporation has registered 79 business line codes under the former classification system. However, after updating the registered business lines in accordance with Decision No. 36/2025/QĐ-TTg, the number of business lines displayed in the system is reduced to 67 codes.

This is because a number of former business line codes have been abolished, consolidated or changed, resulting in the system no longer fully recognizing them as previously recorded.


#### **2. Proposed contents:**

In order to ensure that the Corporation's operations comply with the latest regulations on the Vietnam Standard Industrial Classification System, the Board of Directors respectfully submits to the 2026 Annual General Meeting of Shareholders for consideration and approval the supplementation of the Corporation's business lines, with the following specific contents:

- To update, convert and supplement the business line codes in accordance with the new list under Decision No. 36/2025/QĐ-TTg;


