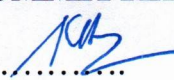
The shareholders present at the meeting fully meet the eligibility requirements to attend the 2025 AGM of the Machines and Industrial Equipment Corporation - JSC.



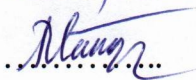
