4. Mr. Nguyen Trung Kien, Officer of the Finance and Accounting Department: Member.

Based on the list of nominees and candidates for election to the Supervisory Board of The Machines and Industrial Equipment Corporation for the 2026–2031 term, as approved by the General Meeting, including:

1. Mr. Pham Minh Duc,
2. Ms. Le Thi Minh Huyen,
3. Ms Phan Thi Le Quynh.



- The Vote Counting Committee presented the Regulations on Nomination, Self-nomination and Election to the General Meeting prior to the voting process.

- Total number of shareholders attending the General Meeting: 13 Shareholders.

- The Vote Counting Committee distributed ballots, supervised the voting process, collected ballots and conducted the vote counting. The results are as follows:

+ Total number of shareholders casting votes: 13 shareholders.

+ Total number of ballots distributed: 13 ballots, representing: 424.896.000 voting rights, accounting for 100% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

+ Total number of ballots collected: 13 ballots, representing: 424.896.000 voting rights, accounting for 100% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

Of which:

+ Valid ballots: 13 ballots, representing: 424.896.000 voting rights, accounting for 100% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

+ Invalid ballots: 0 ballots, representing: 0 voting rights, accounting for 0% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

Vote counting results:

1. Mr. Pham Minh Duc received 125.231.643 votes, accounting for 29,47% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

2. Ms. Le Thi Minh Huyen received 174.425.514 votes, accounting for 41,05% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

3. Ms. Phan Thi Le Quynh received 125.231.643 votes, accounting for 29,47% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

Based on the vote-counting results and the Regulations on Nomination, Self-nomination and Election approved by the 2026 AGM and for the 2026-2031 term, the following individuals have been duly elected as members of the Board of Directors of MIE for the 2026–2031 term (ranked in descending order of votes received):

1. Ms. Le Thi Minh Huyen Number of votes: 174.425.514 accounting for 41,05% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

2. Mr. Pham Minh Duc Number of votes: 125.231.643 accounting for 29,47% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

3. Ms. Phan Thi Le Quynh Number of votes: 125.231.643 accounting for 29,47% of the total voting rights of shareholders attending and eligible to vote at the General Meeting.

These Minutes of Vote Counting consist of three (03) pages, were completed at 11 hours 30 minutes, on 26 June 2026, and were publicly announced to the General Meeting.
